The Government of Mozambique has received a Loan and a Grant from the International Development Association (IDA) and from the Global Environment Fund (GEF) to implement the project entitled "First Project to Support Governance and Growth of the Southeast Indian Ocean Fisheries (SWIOFish1 Mozambique) and intends to apply part of this financing for eligible payments in the Contracting of an Individual Consultant to conduct the **Mid Term Evaluation of the SWIOFish1-Mz Project**
2. Consulting services ("the Services") include:
 - a) Comprehensive analysis of the implementation of SWIOFish1 in Mozambique (components 2, 3 and 4)
 - b) Identification of possible deviations in the implementation and production of recommendations with a view to achieving the objectives and indicators within the deadlines established in the agreements.Detailed service description can be found in the Terms of Reference
3. The duration of the contract shall be 2,5 (two point five) months.
4. The minimum requirements to be selected for the vacancy are as follows:
 - Master's degree(s) or Higher in Fisheries Resource Management/Fisheries Development with not less than 10 years' experience post-qualification.
 - High technical skills in institutional, climate-change mitigation initiatives, natural/fisheries resources management and community participation.
 - Working experience in monitoring and evaluation of complex projects development projects, preferably World Bank-financed projects;
 - Strong analytical skills and experience in analysing quantitative/qualitative data
 - Fluency in Portuguese and English.
