## ENVIRONMENTAL AND SOCIAL COMMITMENT PLAN

- The Republic of Mozambique (Recipient) shall implement the Northern Mozambique Rural Resilience Project (P174635) through the following Project Implementing Entities, namely, the National Fund for Sustainable Development (FNDS), the Blue Economy Development Fund (ProAzul) and BIOFUND, under oversight of the Ministry of Agriculture and Rural Development (MADER) and with the involvement of the Ministry of the Sea, Inland Waters and Fisheries (MIMAIP), Ministry of Land and Environment (MTA), and the Agency for Integrated Development of the North (ADIN). The International Development Association (hereinafter, the Association) has agreed to provide financing for the Project.
- 2. The Recipient shall implement material measures and actions so that the project is implemented in accordance with the Environmental and Social Standards (ESSs). This Environmental and Social Commitment Plan (ESCP) sets out material measures and actions, to be carried out or caused to be carried out by the Recipient, including the timeframes of the actions and measures, institutional, staffing, training, monitoring and reporting arrangements, grievance management and the environmental and social assessments and instruments to be prepared or updated, disclosed, consulted, adopted and implemented under the ESCP and the ESSs, all in a manner acceptable to the Association.
- 3. The Recipient shall also comply with the provisions of any other E&S documents required under the Environmental and Social Framework (ESF) and referred to in this ESCP, such as Environmental and Social Management Framework (ESMF), Environmental and Social Management Plans (ESMP), Security Risk Assessment and Management Plan, Labor Management Procedures (LMP), Gender-Based Violence (GBV) Action Plan, Resettlement Policy Framework (RPF), Process Framework, site-specific Resettlement Action Plans (RAPs), and Stakeholder Engagement Plan (SEP), and the timelines specified in those E&S documents.
- 4. The Recipient is responsible for compliance with all requirements of the ESCP even when implementation of specific measures and actions is conducted by the Ministries, agencies or units referenced to in paragraph 1 above.
- 5. Implementation of the material measures and actions set out in this ESCP shall be monitored and reported to the Association by the Recipient as required under the ESCP and the conditions of the Financing Agreement, and the Association shall monitor and assess progress and completion of the material measures and actions throughout implementation of the Project.
- 6. As agreed between the Association and the Recipient, this ESCP may be revised from time to time during project implementation, to reflect adaptive management of project implementation changes and unforeseen circumstances or in response to assessment of project implementation performance conducted under the ESCP itself. In such circumstances, the Recipient shall agree to the changes with the Association and update the ESCP to reflect such changes. Agreement on changes to the ESCP shall be documented through the exchange of letters signed between the Association and the Recipient. The Recipient shall promptly disclose the updated ESCP.
- 7. Where changes due to unforeseen circumstances, or project performance result in changes to the risks and impacts during implementation, the Recipient shall provide additional funds, if needed, to implement actions and measures to address such risks and impacts which may include, among others, environmental, health, and safety impacts; labor influx; gender-based

violence (GBV) and sexual exploitation and abuse and sexual harassment (SEA/SH) and security risks and impacts.
